GENERAL TERMS AND CONDITIONS OF USE ESRI ARCGIS SOFTWARE:

License allow the Faculty of Environmental and Mechanical Engineering employees and students to install and use a copy of the ESRI software on the private computers for the specific purpose of learning, becoming proficient with, and developing curricula or conducting scientific research. Nonacademic or commercial using of the ESRI software is prohibited.

Each student is entitled to one license per academic year. Software users with one end user license may install and use the software on only one computer.

In the case of a computer change / system reinstallation, the end user is required to **deauthorize** the software on the previous computer / system.

The Academic Site License is an annual term license, at the Faculty of Environmental and Mechanical Engineering is valid from 1st of November 2023 to 31st of October 2024.

By signing this Registration Card, employees/ students will not:

- 1. Sell, rent, lease, sublicense, distribute, lend, time-share, or assign Services or Esri Offerings;
- 2. Distribute or provide direct access to Services or Esri Offerings to third parties, in whole or in part, including, but not limited to, extensions, components, or DLLs;
- 3. Distribute Authorization Codes to third parties;
- 4. Reverse engineer, decompile, or disassemble any Product or Deliverable delivered in compiled form;
- 5. Make any attempt to circumvent the technological measure(s) that controls access to or use of Esri Offerings;
- 6. Store, cache, use, upload, distribute, or sublicense Content or otherwise use Esri Offerings in violation of Esri's or a third-party's rights, including intellectual property rights, privacy rights, nondiscrimination laws, export laws, or any other applicable law or regulation;

- 7. Remove or obscure any Esri or its licensors' patent, copyright, trademark, proprietary rights notices, or legends contained in or affixed to any Esri Offerings, output, metadata file, or online or hard-copy attribution page of any Data or Documentation;
